KP-JV, LLC, a Florida limited liability company (the "Company"), in order to amend its Articles of Organization in accordance with the Florida Revised Limited Liability Company Act (Chapter 605, Florida Statutes) (the "Act"), does hereby deliver the following Articles of Amendment pursuant to the Act:

FIRST: The name of the Company is KP-JV, LLC

SECOND: These Articles of Amendment contain an amendment to the Company's Articles of Organization, as originally filed on August 12, 2023 (the "Articles of Organization"), requiring member and manager approval.

THIRD: The Articles of Organization are hereby amended as follows:
