**ARTICLE I
Name**

ARTICLE VI **Management**

The management of the limited liability company shall be member managed and Gerlach Development Group LLC and Four Generations Group LLC are the initial authorized members until they resign or are replaced by the members.

ARTICLE VII **Continuity of Business**


