

Abstract

ARTICLES OF ORGANIZATION OF THE MULTIFAMILY REAL ESTATE GROUP LL

Article I: Name

The name of the limited liability company (LLC) shall be The Multifamily Real Estate Group LLC (hereinafter referred to as the "Company").

Article II: Principal Place of Business and Registered Agent

The principal place of business of the Company shall be located at 9940 47th Ave, suite 217, Saint Petersburg, FL. 33708. The Company shall maintain a registered agent in the State of Florida as required by law. The initial registered agent of the Company shall be Manuel J Herrera, residing at the aforementioned address.

Article III: Formation

The Company is organized under the Florida Revised Limited Liability Company Act (Chapter 605, Florida Statutes).

Article IV: Purpose and Mission

Article VI: Goals and Collaborations
