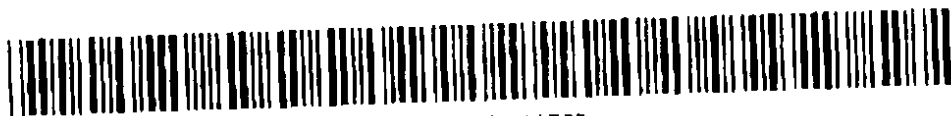

ARTICLES OF ORGANIZATION OF


