The Articles of Organization (the "Articles of Organization") of DBA Trading. LLC (the "Company") are hereby amended to add a new Article VI of the Articles of Organization to read as follows:

#### Article VI

For purposes of Tennessee state law (including Tennessee excise and franchise tax), the Company intends to qualify as an obligated member entity ("OME"), as this term defined in Tenn. Code Ann. § 67-4-2004(34). In view of the foregoing and pursuant to Tenn. Code Ann. § 48-217-101(f), each of DANIEL ASHER, DBA MANAGEMENT, INC., a Florida corporation, and FRED GOLDMAN (the "Member") shall:

- 1. Assume personal liability for all of the debts, obligations and liabilities of the Company to the same extent as a general partner in a general partnership; and
- Continue to be personally liable for debts, obligations and liabilities of the Company to the same extent as a general partner of a general partnership until: (i) such Member withdraws from the Company; or (ii) these Articles of Organization and the relevant OME related documents filed with the State of Tennessee are amended to strike such Member's name as a member electing joint and several liability, provided that the foregoing document must be executed by the Member desiring to cease being so liable and promptly delivered to any remaining Member(s) who are identified in these Articles of Organization and the OME related documents as personally being jointly and severally liable for the debts, obligations and liabilities of the Company.
