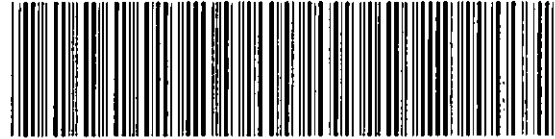



ARTICLES OF ORGANIZATION

OF

3J G4 INVESTMENTS, LLC

I hereby file these Articles of Organization as the authorized representative of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I

NAME

The Company may engage in the transaction of any or all lawful business for which a limited liability company may be formed under the laws of the State of Florida.


ARTICLE VII

Members may be admitted to the Company as provided in the Operating Agreement.


