**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
G4 HOLDING JAX LLC**

1. The Articles of Organization of G4 HOLDING JAX LLC, a Florida limited liability company (the "Company"), were filed on August 23, 2023 and assigned document number L23000397499.

2. These Amended and Restated Articles of Organization were approved by the Members of the Company, to be effective December 27, 2023.

3. These Amended and Restated Articles of Organization are submitted to amend and restate the Articles of Organization of the Company in its entirety to read as follows:

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

Pursuant to § 605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I
NAME**

The name of the limited liability company is G4 Holding Jax LLC (the "Company").

**ARTICLE II
EFFECTIVE DATE AND DURATION**

The effective date upon which the Company came into existence is August 23, 2023. Unless earlier terminated pursuant to the Act or the Operating Agreement (as defined in § 605.0105 of the Act) of the Company, the period of its duration shall be perpetual.

**ARTICLE III
ADDRESS**

The mailing and street address of the principal office of the Company shall be 3813 Coopers Lake Road, Jacksonville, Florida 32224.

**ARTICLE IV






