ARTICLES OF ORGANIZATION OF JW FARM MANAGEMENT, LLC

The undersigned, James C. Watts, Jr., a natural person competent to contract and an authorized representative of JW Farm Management, LLC, hereby presents these Articles of Organization as the Articles of Organization of JW Farm Management, LLC, a limited hability company formed under the provisions of Chapter 605, Florida Stantes.

<u>ARTICLE 1 - NAME</u>

The name of the limited liability company is JW Farm Management, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
