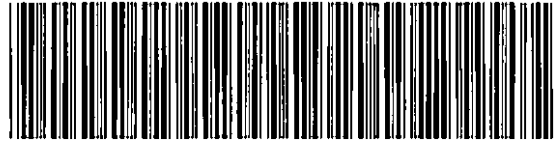



ARTICLE II – ADDRESS:


