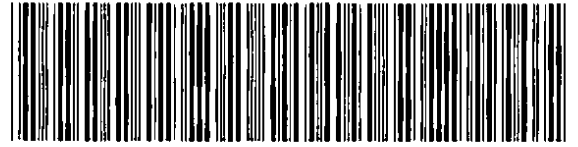

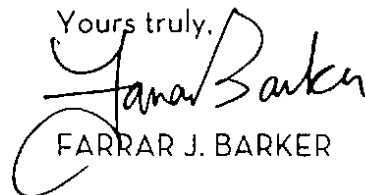

1. The name of the Converting Entity immediately prior to filing of these Articles of Conversion is Claw Consulting Group, LLC.

2. The Converting Entity is a limited liability company first organized under the laws of the State of Alabama on January 12, 2018.

3. The name of the Florida limited liability company as set forth in the attached Articles of Organization is Claw Consulting Group, LLC (the "Converted Entity").

5. The Plan of Conversion has been approved in accordance with the Code of Alabama and the Florida Revised Limited Liability Company Act and has been approved by the sole member of the Converting Entity. The member is not entitled to appraisal rights as the member of the Converting Entity has approved the Plan of Conversion and remains the sole member of the Converted Entity.

The undersigned, Cindy White, a natural person competent to contract and an authorized representative of Claw Consulting Group, LLC, hereby presents these Articles of Organization as the Articles of Organization of Claw Consulting Group, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is Claw Consulting Group, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names and addresses of the initial managers of the Company are as follows:

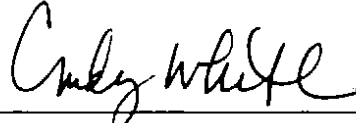

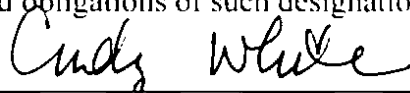
