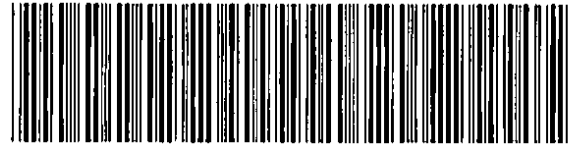

ARTICLE VIII - AMENDMENT


