To manufacture, buy, sell, exhibit and deal in design materials and products, wall papers, lighting, kitchens, floors, plumbing fixtures and furniture, drapes, cabinets, closets. To do interior design, advice and supply plans and materials for the designing and decoration and furnishing of houses, rooms, spaces, apartments. To manufacture, sell, export, import, or otherwise deal in furniture, furnishings, fixtures, fittings, equipment, devices, and articles of all kinds and description made of metal, wood, stone, plastics, or other materials or combinations of materials. To sell and deal in building and constructions materials of every nature and description. To manufacture or otherwise produce, purchase or acquire, sell, let, and deal in goods, wares, merchandise, and personal

To do a general commission business and to accept consignments of merchandise for sale upon commission; to act as selling agents for manufacturers, merchants, mills, and others, and to finance accounts and sales; to provide office and sales forces for manufacturers, mills, and others; to buy and sell all kinds of merchandise; and to act as factors generally.


