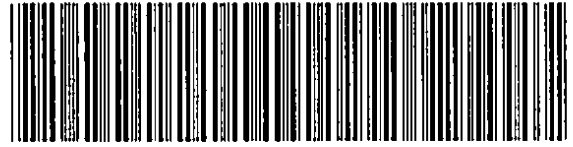

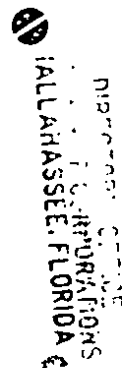



Management



There shall be no cumulative voting.




