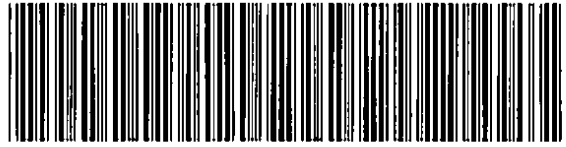

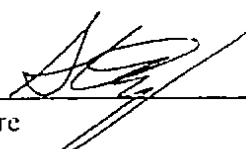

ARTICLES OF ORGANIZATION

OF

MOON RUNNER, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, as amended, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I NAME AND PURPOSE

The name of the Limited Liability Company is Moon Runner, LLC (the "Company"). The purpose of the company shall be owning and operating a vessel.

ARTICLE II ADDRESS

The mailing address and street address of the principal office of the Company is 129 N. Main Street, Brooksville, Florida 34601.

ARTICLE III DURATION

The company shall commence its existence on the date these Articles of Organization are executed by the organizer/member. The Company's existence shall be perpetual, unless the company is earlier dissolved as provided in these Articles of Organization.

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be

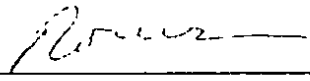

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VI **MANAGEMENT**

The Company shall be managed by its members or designated manager selected by the members in accordance with regulations or operating agreement adopted by the members for the management of the business and affairs of the Company. These regulations or operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
