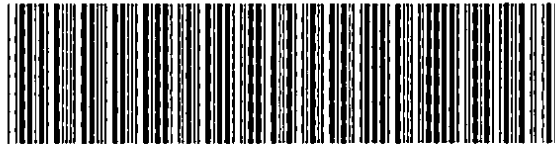




1. The Converting Entity is Decks and Docks Lumber Company, Inc., a Florida corporation formed on February 17, 2005.



**PLAN OF CONVERSION OF  
DECKS AND DOCKS LUMBER COMPANY, INC.,  
A FLORIDA CORPORATION  
TO DECKS & DOCKS LUMBER COMPANY, LLC,  
A FLORIDA LIMITED LIABILITY COMPANY  
PURSUANT TO THE FLORIDA BUSINESS CORPORATION ACT**

This is the Plan of Conversion of Decks and Docks Lumber Company, Inc., a Florida corporation to Decks & Docks Lumber Company, LLC.

1. The converting corporation is Decks and Docks Lumber Company, Inc., a Florida corporation (the "*Corporation*").
