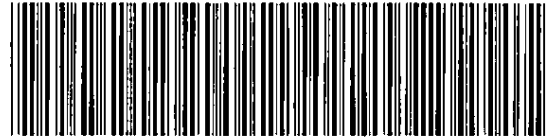

The undersigned, for the purpose of amending and restating the Articles of Organization which were filed September 5, 2023 and assigned Florida document number L23000412179, hereby makes, acknowledges, and files the following

Amended and Restated Articles of Organization

ARTICLE 1 - NAME

*The name of the limited liability company shall be **NAVIGATING NAUTICAL, LLC** ("Company").*

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 100 Sisso Cove Winter Springs, Florida 32708 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4 - DURATION

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE 5-PURPOSES AND POWERS

The general purpose for which the Company is organized is to engage in the business of Boat Rental and Storage and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

have no right to participate in the management of the business and affairs of the Company or
become a member unless all the other member(s) of the Company other than the member
proposing to dispose of his or her interest approve of the proposed transfer by unanimous
written consent.

**ARTICLE 8 -TERMINATION OF
