The undersigned, being authorized to execute and file these articles of organization, hereby certifies that:

1. Name. The name of this limited liability company is **FOUNDATION AG, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "Act").

2. Duration. The Company's existence shall be perpetual, unless terminated in accordance with the Operating Agreement or by the written consent of the members of the Company, and the effective date of commencement of the Company's existence shall be September 7, 2023.
