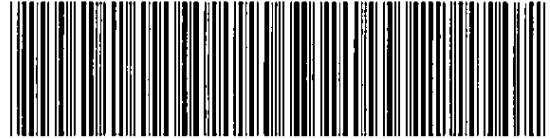

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
HERNANDO ADULT SOCCER**

Under the provisions of F.S. 605.0202, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendments Adopted:

The following Articles are being added:

ARTICLE VII. Said corporation is organized exclusively for charitable, religious or scientific purposes, within the meaning of section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE VIII. No part of net earnings of the corporation should inure the benefit of, or be distributable to its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable Compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c) (3) purposes. No substantial part of the activities of the corporation shall be carrying propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.


ARTICLE IX: Notwithstanding any other provision of these articles, the corporation shall not carry any other activities not permitted to be carried on (a) corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future Federal Tax Code).

ARTICLE X: Upon dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future Federal government, or to a state or local government for a public purpose.

SECOND: The articles were adopted on January 31st, 2024.

THIRD: The director without member action adopted the amendments and member action was not required.
