**Statement of Fact Affidavit  
for  
Florida Limited Liability Company  
by Sole Manager**

I, Ryan D'Amato, a resident of Texas with business address at 142 Minutemen Causeway, Cocoa Beach, Florida, 32931, do swear or affirm under penalty of perjury in Florida, and specifically, under F.S. §817.155, that the following is true:

1. I am over the age of majority, and I make this statement in good faith, of my own free will, and without duress.
2. Pursuant to the Corporate Action dated August 20, 2024, and effective August 30, 2024, I am the sole Manager of COWS IN SPACE, LLC, with Florida Document ID# L23000417389 as of August 31, 2024. By the same action, there remain only two Members of the Company as of August 31, 2024; namely, The Angry Friend, LLC (rep. by James Morrone), and Monkeys Run the Zoo, LLC (rep. by Marco Kozlowski).
3. Pursuant to the same Corporate Action and the sanctions listed therein, Mr. Edward Rose was duly expelled as a member of the Company, and was stripped of all relationship with the Company, effective August 30, 2024.
4. The Company duly noticed Mr. Rose of his expulsion on September 3, 2024, including copies of the Corporate Actions against him, the receipt of which he immediately acknowledged in writing.
5. Despite being fully aware of his expulsion, Mr. Rose has reacted destructively in several vectors, including a reactive Updated Annual Report with FLDOSDOC filing today, September 5, 2024.
6. Mr. Rose is immediately attempting to use his SUNBIZ.org posting today to support additional fraud with Florida institutions, including banks and payment processors.
7. The Company filed its Amended and Restated Articles of Organization on September 3, 2024, by courier, to be effective immediately (see Article II).
8. In conclusion, Mr. Rose's subsequent updated annual report filing on this day must be invalidated immediately (for both reasons of his expulsion and lack of authority to file with FLDOSDOC on behalf of the Company), and safeguards erected to prevent his further fraud. The Company supports a F.S. §817.155 criminal investigation of Mr. Rose for his fraudulent filing in coordination with appropriate agencies.



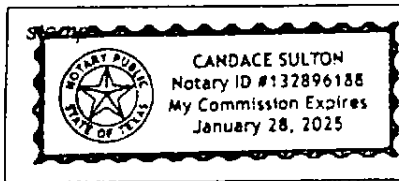


