The undersigned, as the organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

The Name of the Company is EMERSYN MAE, LLC, a Florida limited liability company.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence upon filing these Articles with the Florida Department of State, and shall continue perpetually unless dissolved in accordance with Section 608.441 of the Florida Statutes.

The Company is created to conduct any lawful business under the laws of the State of Florida.

ARTICLE V

Registered Agent and Office

The initial registered agent for the Company for service of process shall be Jason V. Fielding, and the address of the registered agent is 3082 University Parkway, Sarasota, FL 34243.

ARTICLE VI

Management of Business

ARTICLE XI

Operating Agreement


