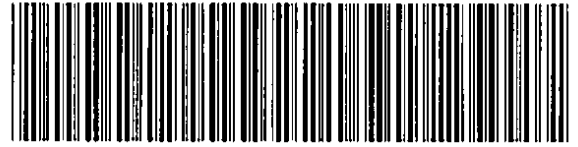



ARTICLE VII
MEMBERSHIP

7.01 Membership

The only member of PENITENT THIEF TRANSPORTATION LLC shall be The Penitent Thief, Inc., a Florida limited liability company. The management of the affairs of the company shall be vested in a board of managers as defined in this Article of Organization or the Operating Agreement of the company.

The duration of the company shall be perpetual but only for so long as The Penitent Thief, Inc., the sole member of this company is in existence and is a 501(c)(3) qualified organization.

ARTICLE IX

PURPOSE

9.01 Purpose

PENITENT THIEF TRANSPORTATION LLC is a non-profit company and shall operate exclusively for educational, charitable and religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. The purpose of PENITENT THIEF TRANSPORTATION LLC, shall be to provide services to THE PENITENT THIEF, INC. in support of its mission to prepare persons who are incarcerated to leave incarceration and thereafter assist them in successfully transitioning back into society following their incarceration. PENITENT THIEF TRANSPORTATION LLC's primary purpose will be to provide transportation for returning citizens to enable them to meet the conditions of their release such as visiting parole officers, and to attend training programs intended to provide them with skills and training to make them successful in society and to get and keep employment. The goal is to assist persons enrolled in the programs of THE PENITENT THIEF, INC. to successfully make the transition into society and become self-sufficient.

9.02 Non-Profit

PENITENT THIEF TRANSPORTATION LLC will operate as if it were designated as a non-profit corporation under IRS Code Section 501(c)(3), and to fully support the non-profit and charitable activities of THE PENITENT THIEF, INC.

ARTICLE X

NON-PROFIT NATURE

10.01 Non-profit Nature

PENITENT THIEF TRANSPORTATION LLC is organized exclusively for charitable and educational purposes. No part of the net earnings of PENITENT THIEF TRANSPORTATION LLC shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the company shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

PENITENT THIEF TRANSPORTATION LLC is not organized and shall not be operated for the private gain of any person. The property of the company is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the company shall inure to the benefit of, or be distributed to, any individual. The company may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles and for a fair price.

10.02 Personal Liability

No officer or director of this company shall be personally liable for the debts or obligations of PENITENT THIEF TRANSPORTATION LLC of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this company.

10.03 Dissolution

Upon termination or dissolution of PENITENT THIEF TRANSPORTATION LLC any assets lawfully available for distribution shall be distributed first to THE PENITENT THIEF, INC., if but only if it is a 501(c)(3) qualified organization at the time of distribution, and if not to THE PENITENT THIEF, INC. then to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving company.

The organization to receive the assets of PENITENT THIEF TRANSPORTATION LLC hereunder shall be selected by the discretion of a majority of the managing body of THE PENITENT THIEF, INC. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition filed in a court of proper jurisdiction in the state of organization of PENITENT THIEF TRANSPORTATION LLC against PENITENT THIEF TRANSPORTATION LLC by one (1) or more of the managing body of THE PENITENT THIEF, INC., which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this company, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

10.04 Prohibited Distributions

No part of the net earnings or properties of this company, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the

purposes of THE PENITENT THIEF, INC. Distributions may be made to third parties who are not 501(c)(3) qualified organizations but only in return for payment of fair market thereof.

10.05 Restricted Activities

No substantial part of the company's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the company shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

10.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the company shall not carry on any activities not permitted to be carried on (I) by a company exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by an entity, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


ARTICLE XI **AMENDMENTS**

11.01 Amendments

Any amendment to the Articles of Organization may be adopted by approval of two-thirds (2/3) of the board of managers, but subject in any event to the restriction on amendments set out in the Operating Agreement of PENITENT THIEF TRANSPORTATION LLC.
