1. Name. The name of the Limited Liability Company shall be McCAMPBELL REALTY THREE, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 2613 Furman Lane, Lake Worth, Florida 33460.
