
ARTICLE VII



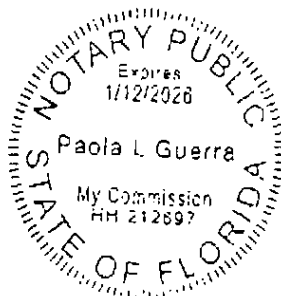


