

**ARTICLES OF ORGANIZATION
FOR
SERVICES CAPITAL FL V LLC**

1. The name of the limited liability company is **Services Capital FL V LLC** (the "**Company**").
2. The address of the principal office of the Company, which is identical to the mailing address of the Company, is 4401 Fairfax Drive, Suite 800, Arlington, Virginia 22203, Attention: David Brody.
