ARTICLES OF ORGANIZATION
of
HUCKLEBERRY'S LOWCOUNTRY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Huckleberry's Lowcountry, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 12842 River Story Way, Jacksonville, Florida 32223.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

The Company shall be terminated and dissolved pursuant to the terms of the Company's operating agreement, which may be amended from time to time, or in the absence of an operating agreement, by the Act.

ARTICLE VII**DURATION AND COMMENCEMENT**




