**ARTICLES OF ORGANIZATION  
OF  
TROUT RIVER GOODS, LLC  
A LIMITED LIABILITY COMPANY**

Pursuant to Section 605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, as amended from time-to-time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I  
NAME**

The name of this limited liability company (the "Company") is Trout River Goods, LLC.

**ARTICLE II  
DURATION**

The effective date upon which the Company shall come into existence shall be the date these Articles of Organization are filed. Unless terminated earlier pursuant to the Act or the Operating Agreement (as defined in section 605.0105 of the Act) of the Company. The duration shall be perpetual.

**ARTICLE III  
PRINCIPAL OFFICE**

**ARTICLE IV  
REGISTERED OFFICE AND AGENT**
