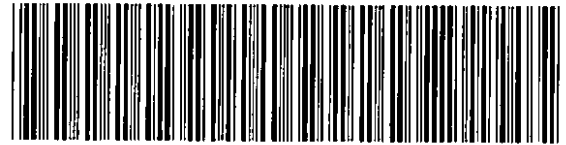

FOR
