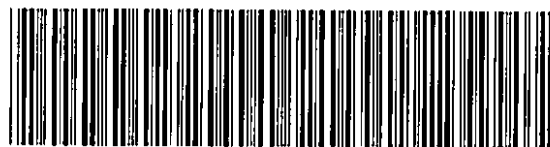

**ARTICLES OF ORGANIZATION
FOR
SERVICES CAPITAL FL I LLC**

1. The name of the limited liability company is **Services Capital FL I LLC** (the "**Company**").
