ALLAHASSEE, FL The undersigned, an authorized representative of a prospective member, desiring to form a limited liability company under the Florida Revised Limited Liability Company Act. Chapter 605, Florida Statutes, hereby adopts the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company is ASM Publications, LLC (the "Company").

#### ARTICLE II - ADDRESS
