

## ARTICLES OF ORGANIZATION OF HEALTHTEX DISTRIBUTORS LLC

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida, including activities within the United States and abroad.


#### ARTICLE VIII ADDITIONAL MEMBERS
