The undersigned, Yancey Lovelace, a natural person competent to contract and an authorized representative of Gulf Coast Partners Insurance, LLC, hereby presents these Articles of Organization as the Articles of Organization of Gulf Coast Partners Insurance, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Gulf Coast Partners Insurance, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."


ARTICLE VI – MANAGEMENT


