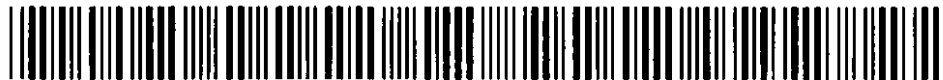




**ARTICLE XI**
