Amended and Restated Articles of Organization of the ISI South Equipment LLC

A Florida Limited Liability Company

Section 1.01 Introduction and Preliminary Statements

The undersigned Manager desires to amend ISI South Equipment LLC, a limited liability company under the Laws of the State of Florida, by delivering these Amended and Restated Articles of Organization in duplicate to the Secretary of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act (the *Act*). Section 1.09 Additional Contributions

Section 1.10 Additional Members

The Company has the right to admit additional Members to the Company under the terms and conditions of the Company's Operating Agreement. Any Member who is later admitted as a Member of the Company will have all of the rights and obligations of an
