ARTICLE 1 – NAME

ARTICLE 2 – ADDRESS

The principal place of business of the Company in Florida shall be 18305 Biscayne Blvd, Suite 216, Aventura, FL 33160 and the mailing address shall be the same.

These Articles of Organization shall be effective immediately upon approval of the Secretary of State of Florida.


ARTICLE 9 – MANAGEMENT
