## ORGANIZATION FOR SMALLMAN HOLDINGS, LLC, A FLORIDA LIMITED LIABILITY COMPANY

### ARTICLE I. NAME

The name of the Limited Liability Company is "Smallman Holdings, LLC" (the "Company").

#### ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Company is 1720 SE 16<sup>th</sup> Avenue, Building 100, Ocala, Florida 34471.

#### ARTICLE III. DURATION

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Limited Liability Company Act*. Sections 605.0101 through 605.1108 of the *Florida Revised Statutes Annotated* (the "Act") or the Company's Operating Agreement among the members (the "Operating Agreement").

#### ARTICLE IV. MANAGEMENT
