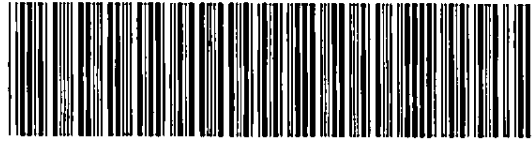

**ARTICLE I.  
NAME**

The name of the Limited Liability Company is "*Smallman Holdings, LLC*" (the "*Company*").

**ARTICLE II.  
ADDRESS**

The mailing address and street address of the principal office of the Company is 1720 SE 16<sup>th</sup> Avenue, Building 100, Ocala, Florida 34471.

**ARTICLE III.  
DURATION**

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Limited Liability Company Act*, Sections 605.0101 through 605.1108 of the *Florida Revised Statutes Annotated* (the "*Act*") or the Company's Operating Agreement among the members (the "*Operating Agreement*").

**ARTICLE IV.  
MANAGEMENT**

The Limited Liability Company is to be managed by a Manager or Managers. The initial Managers shall be David Tillman and Brian M. Smallwood.

**ARTICLE V.  
PURPOSE**

The purpose for which the Company is being organized is to acquire, improve, operate, develop, and lease, and ultimately resell, real and personal property, or notes, mortgages and other obligations secured by real property, and to transact any other lawful business approved by the members of the Company and for which a limited liability company may be formed under the laws of the State of Florida.

The Company reserves the right to amend, alter, change or repeal any provision contained in these Articles of Organization, in the manner now or hereafter prescribed by the Act.


