

ARTICLES OF ORGANIZATION OF NICEAMALLC

The undersigned, intending to form and create a Limited Liability Company, as defined in Chapter 605 of the Florida Statutes; hereby files these Articles of Organization and states:

ARTICLE I NAME AND ADDRESS

ARTICLE II REGISTERED AGENT AND OFFICE
