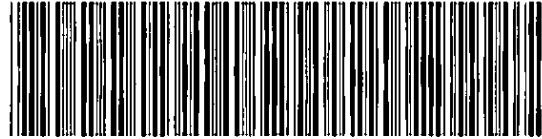



Registered Agent and Office




