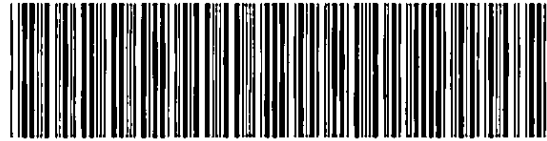


ARTICLE III


