MANAGEMENT

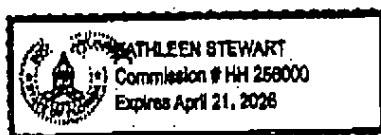


