Pursuant to the provisions of §§ 605.1021-1026 of the Florida Revised Limited Liability Company Act (the "Act"), Merritt Island Medical Research, LLC, a Florida limited liability company ("MI Medical"), and Merritt Island Research, LLC, a Florida limited liability company ("MI Research"), approve and submit the following Articles of Merger to effectuate a merger of MI Medical with and into MI Research (the "Merger"):

**FIRST:** The plan of merger for the Merger (the "Plan of Merger") is attached to these Articles of Merger.

**SECOND:** The Plan of Merger was properly approved by unanimous written consent of the Members of MI Medical, dated as of October 24, 2023, and by unanimous written consent of the Members of MI Research, dated as of October 24, 2023, which consents include approval by all members who, as a result of the Merger, will have an interest holder liability under § 605.1023(1)(b) of the Act, and whose approval is required.

**THIRD:** There is no amendment necessary with regard to the Articles of Organization of the surviving entity (MI Research).

**FOURTH:** The surviving entity has agreed to pay to any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of §§ 605.1006 and 605.1061-605.1072 of the Act.

**FIFTH:** The Merger shall be effective as of the date these Articles of Merger are filed with the Florida Department of State.

Each of MI Research and MI Medical have caused these Articles of Merger to be signed in their respective corporate names and on their behalf by an authorized officer, as of October 24, 2023.

**AGREEMENT AND PLAN OF MERGER**

Pursuant to the provisions of §§ 605.1021-1026 of the Florida Revised Limited Liability Company Act (the "Act"), Merritt Island Medical Research, LLC, a Florida limited liability company ("MI Medical"), and Merritt Island Research, LLC, a Florida limited liability company ("MI Research"), approve and submit the following Agreement and Plan of Merger (this "Plan") to effectuate a merger of MI Medical with and into MI Research (the "Merger"):

**WHEREAS**, MI Medical and MI Research desire to effect the Merger of MI Medical with and into MI Research;

**WHEREAS**, the Members and Managers of MI Medical and MI Research have or will each approve the Merger upon the terms and subject to the conditions set forth herein and deem it advisable and in the best interests of their respective owners that the Merger be consummated;

**WHEREAS**, following the Merger, MI Research will be the surviving entity and all of the membership interest of MI Medical shall be cancelled, null and void; and

**WHEREAS**, there are no members of MI Medical who are entitled to appraisal rights.

For consideration, the receipt and sufficiency is hereby acknowledged, MI Research and MI Medical agree as follows:

1. The above recitals are incorporated into this Plan and acknowledged as being true.
2. MI Medical and MI Research agree to merge, and that MI Research will be the surviving entity.
3. The surviving entity will pay to any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of §§ 605.1006 and 605.1061-605.1072 of the Act.
3. The Merger shall be effective as of the date the Articles of Merger are filed with the Florida Department of State.
