The Articles of Incorporation for Florida West Charters Incorporated were filed electronically (by me) on September 28, 2021, effective October 1, 2021, with the assigned document number P21000084797. Unfortunately, the COVID-19 pandemic caused boat prices to skyrocket, and I could not afford to invest in the company in 2021. The company sat dormant with no economic activity (e.g., revenue or expenses) and was revoked last year.

Now that business conditions are more favorable, I am trying to establish Florida West Charters LLC, a more suitable tax structure for the business.
