## ARTICLES OF ORGANIZATION

#### <u>OF</u>

The undersigned, for the purpose of forming a limited liability company under the Florida Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization:

#### **ARTICLE I**

#### **NAME**

#### ARTICLE V

#### **PROFIT & LOSSES**

- 1) <u>SHARING OF PROFITS:</u> The members shall be entitled to the net profits arising from the operation of limited liability business that remains after the payment of the expenses of operating the business of the limited liability company. Each member shall be entitled to their distributive share of the profits according to their percent of interest in the company.

#### **ARTICLE VIII**

#### MEMBER'S RIGHT TO CONTINUE BUSINESS
