The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

ARTICLE I
NAME & ADDRESS

The name of this limited liability company shall be **26611WC, LLC** (the "Company") and its principal office address is 26615 Wesley Chapel Blvd., Suite 3, Lutz, Florida 33559, and its mailing address is P.O. Box 7078, Wesley Chapel, Florida 33545.

ARTICLE II
EFFECTIVE DATE

ARTICLE III




