ARTICLE I

NAME

The power to alter, amend or repeal these regulations shall be vested in all the members of this company.

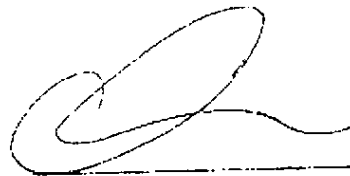
ARTICLE VI PROPERTY

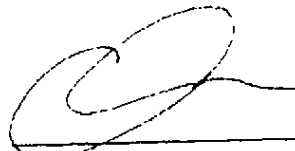
