### ARTICLES OF ORGANIZATION

#### <u>of</u>

#### VERAI MAA LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization:

#### **ARTICLE I**

#### NAME

The name of this Limited Liability Company shall be VERAI MAA LLC.

#### **ARTICLE II**

#### **ADDRESS**

#### ARTICLE V

#### PROFIT & LOSSES

- 1) SHARING OF PROFITS: The members shall be entitled to the net profits arising from the operation of limited liability business that remains after the payment of the expenses of operating the business of the limited liability company. A member may transfer his or her interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

#### **ARTICLE VIII**

#### MEMBER'S RIGHT TO CONTINUE BUSINESS

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided that it has at least one remaining member.

#### **AMENDMENT OF ARTICLES OF ORGANIZATION**
