ARTICLES OF ORGANIZATION

OF

LITTLE ROUND FACE, LLC

The undersigned acting as the organizer of LITTLE ROUND FACE, LLC, under the Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopt the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is <u>LITTLE ROUND FACE, LLC</u> (the "Company").

ARTICLE II - Address:

The mailing address of the limited liability 340 Royal Poinciana Way Suite 328, #1147, Paint Beach, Florida 33480 and the principal office of the limited liability company is c/o Paracorp Incorporated, 155 Office Plaza Drive, 1st Floor, Tallahassee, Florida 32301.

ARTICLE III - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or Operating Agreement of the Company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a manager or officer existing at the time of such repeal or amendment.

ARTICLE X - Member Interests:

The Company is authorized to issue both voting and nonvoting membership interests. All membership interests shall be identical in all respects except the nonvoting membership interests shall carry no right to vote on any matter except as the State of Florida requires that voting rights be granted nonvoting membership interests.
