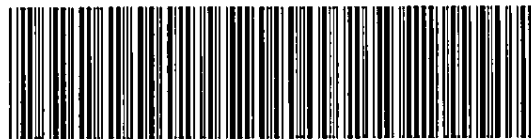

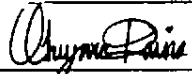

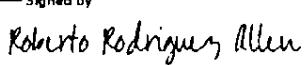
- (b) The date of filing of the original Articles of Organization assigned document number L23000492021 is October 27<sup>th</sup>, 2023.
