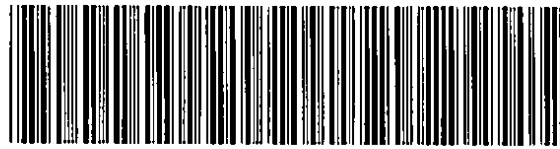

**ARTICLES OF ORGANIZATION
OF
IDEAS INTERNATIONAL SERVICES, LLC**

The undersigned, being the manager, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is Ideas International Services, LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal office address is 1415 20th Street, Unit 403, Miami Beach, FL 33139 and the mailing address is 1415 20th Street, Unit 403, Miami Beach, FL 33139.

**ARTICLE III

ARTICLE VI
PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

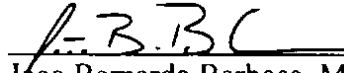
ARTICLE VII
