**ARTICLES OF AMENDMENT

**WHEREAS**, the name of the company is GARRETT ADAMS RACING LLC, a Florida limited liability company ("Company"); and

**WHEREAS**, the Organizer of the Company has recommended the amendment to the Articles of Organization set forth below; and

**WHEREAS**, the undersigned Company, by and through its Organizer and pursuant to the provisions of the Florida Statutes, agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth:

**NOW, THEREFORE**, the undersigned hereby amends the Articles as follows:

1. Article IV of the Articles of Organization is hereby modified and is restated as follows:


**"ARTICLE IV  
MANAGEMENT**

The Company shall be managed by the Manager of the Company as provided in the Company's Operating Agreement.
